Gary showcased the generic template, there is potential for this to be used across the West Midlands following the Pilot.

Gill Thomas agreed to pilot the tool and to share learning.

9. Referral Criteria (24 Hour Healthcare)

The aim is to develop a referral criterion in an in-patient setting.

Group felt that this was not appropriate and that physical ill health is deemed to be more complex therefore could this take priority.

Intermediate care is required, as there are issues around supervision.

Action: Refer agenda item to RGN Forum in the first instance
